Membership Information

The **Sunnyvale Rod & Gun Club** is a sportsmen's organization. It is a non-profit corporation that has served our community for over 49 years. In accordance with our bylaws, we offer several classes of membership, two of which apply to new members. These are the **Probate Regular Membership** and the **Special Membership**.

The **Probate Regular Membership** is the first stage in a sequence towards becoming a **Full Regular Member**. All **Regular Members** of the club pay \$50.00 annual dues and perform work assignments for the maintenance and continued operation of the club.

As a **Probate Regular Member** you will stand range duty and/or trap duty as scheduled by the Membership Committee Chairman. You will be required to perform at least 20 hours of work time as a Probationary Member. You have up to one year to complete the probationary requirements (minimum 6 months). You must attend at least four general meetings as a Probate to be eligible for advancement to Associate Membership status. As a Probate you may shoot at current member rates and attend club functions i.e., fishing trips, hunting trips, BBQ's, etc. Upon completion of your probationary period the **Full Regular Members** present at the General Meeting will vote on your advancement to **Associate Regular Member**. You will be required to attend that meeting. If you cannot attend, the vote will be postponed until the next meeting.

As an **Associate Regular Member** your immediate family members also receive most of the same benefits. You can purchase items through the club for your own use with the club's FFL (Guns, ammo, reloading supplies, etc.). You will be given the gate combination, so you can shoot or work after public shooting hours up to our maximum hours of operation at the time. You will again be required to perform at least 20 hours of work time and must attend at least four general meetings during your Associate period. After six months as an **Associate Member** you will be voted on for advancement to **Full Member**. You will be required to attend that meeting. If you cannot attend, the vote will be postponed until the next meeting.

As a **Full Member** you will have full voting privileges, and you are eligible to be on the Board of Directors, and vote on all club matters.

To join the club as a Probate Regular Member you must:

1. Be at least 18 years old
2. Be a citizen of the United States of America
3. **Attend a General Membership meeting at the clubhouse.** General Membership meetings occur on the **1st Thursday** each month at 7:00 PM. **DO NOT MAIL THIS APPLICATION!** At the meeting:
 - a. You must pay a \$250.00 non-recurring initiation fee,
 - b. You must pay prorated dues based on a July 1st to June 30th membership year, and the following year if applying between Feb. 1st and June 30th.
 - c. You must bring proof that you are an NRA member (an American Rifleman mailing label is fine). If you are not an NRA member, you must apply online at <http://www.nrahq.org/forms/signup.asp> and bring the confirmation e-mail.

The **Special Membership** is designed for people who are unable to perform required duties around the club. There are a limited number of these memberships. These members pay \$400.00 per year.

Special Members shoot at member rates. They can shoot during normal hours or, if accompanied by a **Full Member**, when the club is closed to the public. Special memberships are not voting memberships.

To join the club as a Special Member you must:

1. Be at least 18 years old
2. Be a citizen of the United States of America
3. **Meet with the Board of Directors to gain their approval.** This can occur at a General Meeting (1st Thursday of each month at 7:00 PM) or at a Board Meeting on the following Monday -- both at the clubhouse.

DO NOT MAIL THIS APPLICATION!

At the meeting:

- a. You must pay a \$250.00 non-recurring initiation fee,
 - b. You must pay prorated dues based on a July 1st to June 30th membership year, and for the following year if required.
 - c. You must bring proof that you are an NRA member (an American Rifleman mailing label is fine). If you are not an NRA member, you must apply for membership online and bring the confirmation e-mail.
4. **Attend a General Membership meeting at the clubhouse.** These occur on the **1st Thursday** of each month at 7:00 PM. At this meeting the voting members present may elect you to be a **Special Member**.
